The Mandal Educational officer, Narasaraopeta has inspected and submitted her report in the reference 3rd cited.

After careful examination of the proposals from the society and also the inspection report of the inspecting officer in the reference 5th cited permission is hereby accorded for Opening of the Educational institution by K- RIDGE School, Jonnalagadda Village, Narasaraopet, Palnadu District from the academic Year 2023-2024 without any aid now or in future, subject to the following conditions

- 1 That the society shall abide to the rules and regulations made in the Government orders in 1st to 3rd cited above.
- 2 That the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, Library, Laboratory equipment, play field, required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
- 3 That the society shall apply for recognition by 31st August at the latest duly fulfilling the conditions
- 4 That the permission accorded is restricted to this year only and it is not valid for the subsequent academic years.
- 5 That this permission does not confer any right on the society for claiming recognition.
- 6 That the permission is accorded to Krishnaveni Society for Education and Development services and no other society or body can open a school on their behalf.
- 7 That the permission is accorded to open the school premises in the locality and they shall not be any change in the premises or locality.
- 8 That the society shall provide the necessary material even if it costs more than the deposit amount.

- 9 That the Institution shall adopt curriculum and syllabus from time to time
- 10 That the school timings, vacations and mid-term holidays shall be prescribed by the Government from time to time
- 11 That the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
- 12 That the list of governing body shall be furnished to the District Educational officer, every year.
- 13 That the records/Accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
- 14 That the results of the institution shall be satisfactory every year.
- 15 That the pay structure/fee structure fixed by the governing body shall be submitted to the District Educational Officer, every year.
- 16 That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- 17 That it shall not be close without giving notice both to the parents / District Educational Officer and the competent authority at least 6 months before.
- 18 That the school shall be closed are permitted to be closed only from the date on which summer vacation is declared.
- 19 The management shall obtain renewal of No Objection Certificate from Fire Service Department every year as per rules.
- 20 Parent teachers association should be formed as per G.O.Ms.No. 216 dt. 17-10-86 every year.




